Sale Process

Appointment of Trustee

D. Kwasnicky & Associates Inc. was appointed Trustee of the estate of Scoff's Hockey Shop (1992) Ltd. on September 7, 2007 pursuant to a voluntary assignment in bankruptcy.

Background

Scoff's Hockey Shop (1992) Ltd. was incorporated in British Columbia on August 4, 1992 in the retails sports equipment business. The business has operated in Pitt Meadows, BC near the intersections of Lougheed Highway and Harris Road.

Assets for Sale

The assets included for sale in this information package have been broken down into six lots:

- Lot 1: Lacrosse equipment inventory;
- Lot 2: Hockey equipment inventory;
- Lot 3: Baseball equipment inventory;
- Lot 4: Miscellaneous sports equipment inventory;
- Lot 5: Fixtures and sports equipment; and,
- Lot 6: Leased premises.

Lots 1 to 5

Lots 1 through 5 consist of miscellaneous sports equipment as detailed in Appendices A to E. A photograph of the skate sharpening equipment is in Appendix F.

Lot 6

Lot 6 consists of the premise lease. The 1,168 square foot retail premises are located in a building on McMyn Road in Pitt Meadows (one block from Lougheed Highway and Harris Road). There are three retail units in the building currently occupied by Scoff's, a salon spa and a fast food pizza takeout.

The Company has a lease agreement with the owner dated August 1, 1992, which is currently under its 7th renewal term, expiring July 31, 2009. The base rent under the lease is \$1,392 per month with estimated additional rent payable of approximately \$841 per month.

3. All offers shall be in writing, signed by the duly authorized officer(s) of the entity making the offer (the “Party” or the “Offeror”) and in the form prescribed by the undersigned.
4. In respect of each purchase, the offer and acceptance thereof, together with the Terms and Conditions of Sale, which shall be deemed to form part of such offer, shall constitute a binding agreement of purchase and sale.
5. All offers must be accompanied by a bank draft drawn by or certified cheque drawn on a Canadian chartered bank payable to “D. Kwasnicky & Associates Inc. – In trust” for an amount not less than 15% of the total gross purchase price offered. identification only and no condition, warranty or representation has been or will be given by the Vendor concerning the accuracy, completeness or any other matter concerning those descriptions.

11. All offers will be accepted on the basis that the Offeror has inspected the assets, that it has relied entirely on its own inspection and investigations, and that it is purchasing the Vendor's right, title and interest, if any, in the Assets on an **"as is, where is"** basis. The Vendor expressly excludes and disclaims from any such sale arrangement, any and all warranties, conditions, undertakings and representations as to title, encumbrances, description, quality, quantity, cost, condition, merchantability, assignability, size and fitness for a particular purpose or as to any other matter whatsoever. Without limiting the generality of the foregoing, no condition, warrants or representation provided for or implied by the *Sale of Goods Act* has been or will be given by the Vendor and the Purchaser expressly waives all such express or implied conditions, warranties and representations. 16. The Assets shall be and remain at the risk of the Vendor as its interest may appear until closing. From and after the time of closing, the Assets shall be at the risk of the Purchaser.
